D. Ongoing Business

- 1. Next Board of Directors Meeting scheduled for January 13, 2024 @ 3pm MT
- Roof repair update:

H/J repair work is done, contractor ordered parts for finishing up the broken vents on metal parts of rest of buildings and a few bubbles in the metal they'll fix. Roofs are in good shape, main issue is pitch angles around chimneys on H/J

- Cable TV contract expiring Dec 2023:
- Still will be ending. SC Broadband now offers 1GB speeds to our complexes for \$65 a moth
- 4. Partial board put on Deck entrance from H stairwell to prevent dogs from pooping/peeing on the common deck in the Winter is a future option. MJ opposed to blocking of the hole deck which will prevent it from be accessed in the winter. For now MJ will get a camera for her window to watch the deck to see what pet activity we can see to assess.
- 5. Gas line cover had a shelter. Owner in J had show removed from J roof which likely caused the shelter to collapse and caused a gas leek. Dominion Gas came onsite and said they can do the 2 snow shelters needed for \$500 each. Dominion also stated the lines into the buildings are compromised and Michael has secured those lines. Michael will build those shelters.
