D. Ongoing Business

- 1. Set date for next Board of Directors Meeting
- 2. General snow removal update
 - a. Snow plow contract renewal for 2024/25
- 3. Roof repair update
 - a. Small issue on J that Andrey fixed
- 4. Look at putting lock boxes on external HOA plugs
- 5. Pet poop/pee on Common Deck
 - a. Hasn't been an issue so far this year
- 6. J Gas line cover shelter updated to get us by for the winter. Will need finished up in the Summer
- 7. Exterior paint update, project cost 30k, was projected at 20-25k. The volunteers were able to get a lot more done this year than expected. We appreciate their work

- 1. Laundry room pricing increase proposal
 - a. \$2.00 (+.25 to hot wash) to wash and \$1.75 to dry
- 2. Bldg F
 - a. Stairwell camera on common wall
 - i. Curtis will remove soon, it's not currently working. Will look to do a Ring
 - b. Water room electrical repairs
 - i. Reimburse F4 for use of their power
 - ii. Common line breaker was tripped
 - c. Common washer/dryer directions, F4 remains approved to have the units and is the sole owner as is

- d. F1 on/off valve smart water valve request approved. Does not replace the need to still drain-down per policy
- e. The BOD will explore possible ways to use smart technology for drain down valves
- f. F1 would like to possibly have a licensed electrician pull power to their garage and their common room for their Smartvalve. Request approved.
- g. F1 will repaint the stairs when warmer
- 3. Water Heaters are home owners and they can strap a water heater strap if they feel it is unstable
- 4. Parking issues:
 - a. in front of fire hydrant
 - i. add more signage?
 - b. in front of garages
 - c. Update on Chalet Village using permits, they just started so we'll get an update in Annual meeting
- 5. Water policy amendment: Test a change to the water shutoff policy from Feb 1 until July's Annual meeting. Water needs to be turned off the same guest departs by 7pm. If you have a guest arriving after 7pm, just send the HOA an email so we know someone is still coming.
